- Prohibit the use of forced or involuntary labor in any form.
- Prevent modern slavery and human trafficking.
- Ensure that no child labor is used.
- Promote diversity and inclusion and ensure that all employees are treated fairly and not are subject to harassment regardless of gender, religion, age, disability, sexual orientation, political orientation, race or any other protected characteristic.
- Provide safe and healthy working conditions.
- Respect the principles of freedom of association and collective bargaining as fundamental human rights.
- Personal data protection (GDPR)
- Wages and benefits: Wages are based on job responsibilities, individual performance, market benchmarks and union appointed guidelines.
- Working hours: Comply with the Working Time Directive and minimize overtime.

- Fair competition.

- Promptly handle and report conflicts of interest.
- Protect and respect intellectual property.
- Choose business partners that comply with the principles in this Supplier code of conduct.
- Promptly report any violations of this Supplier Code of Conduct or any legal breaches.
- Controls regarding exports, trade and economic sanctions.
- Pass on these sustainability requirements towards tier-1 suppliers in the supply chain.

Implement Corrective Actions: Promptly address any non-compliances identified during assessments and audits by developing and implementing a corrective action plan. Failure to comply with this Supplier Code of Conduct may result in various actions, including termination of the business relationship with Dansk Auto Logik A/S.
